In accordance to Article 74 and 75 of the Law on Higher Education („Official Gazette of the Sarajevo Canton“ No. 42/13), in line with the Proposal Decision no. IUS-SENAT 11-2013/2015 dated July 21st 2015, International University of Sarajevo (IUS) publishes

ANNOUNCEMENT

For the student enrolment into the first year of the first study cycle of the Faculty of Law of the International University of Sarajevo for the 2015/2016 academic year

Faculty of Law of the International University of Sarajevo (IUS) enrolls students into the first year of the first study cycle for the academic 2015/2016 as follows:

Lectures at Faculty of Law at IUS are conducted in English language. Assigned period for successful completion of study is four years or eight semesters. Study at IUS is organized in accordance to the Bologna study system; specifically, in line with the model 4+1+3. Students who graduate will receive a bilingual diploma in English language and in one of the official languages of constitutive nations of Bosnia and Herzegovina.

Tuition fee for IUS students who are citizens of Bosnia and Herzegovina is 3.850,00 euros per year, and for foreign students it is 5.500,00 euros per year (or the equivalent amount expressed in BAM according to the median exchange rate of the Central Bank of Bosnia and Herzegovina).

IUS will provide a certain number of scholarships (reduced tuition fee) for eligible students who fulfill criteria for scholarship in accordance to the Founder's regulations.

Citizens of Bosnia and Herzegovina and foreign citizens with finished four-year-high school in Bosnia and Herzegovina have equal right to apply, as well as applicants who finished high school outside of Bosnia and Herzegovina, pending the validation of their high school diploma through equivalency process, to verify that they have the relevant education to continue education.

Admission and enrolment of applicants in the first year of the first cycle of study will be undertaken by special commission appointed by appropriate authority within University.

Ranking and selection of applicants for the enrolment in the first year of Faculty of Law will be made in accordance to applicants high school academic achievement. In case that IUS has filled the quota of planned number of students from Bosnia and Herzegovina or foreign students, IUS reserves the right to enroll the number beyond the quota, in such way that total number of foreign and domestic students do not exceed number which is determined by this announcement.

In case the number of applicants who fulfill the criteria for admission is higher than announced number of students who can be admitted, preference will be given to the candidates who obtained IUS scholarship while the other candidates are ranked on the basis of the success achieved during their previous education.

Candidates applying for enrollment are obliged to submit English language certificate or pass the Proficiency exam in accordance with the criteria prescribed by the IUS general acts. In case of non compliance with the criteria used for determining necessary English Language proficiency, candidate is obliged to successfully finish English Language School.

Along with fulfillment of the above mentioned criteria, students from the Republic of Turkey need to take the entrance exam for undergraduate studies (LYS-Lisans Yerleştirme Sınavı) and to have a minimum score as set by the competent body for High Education of the Republic of Turkey, which means a total of 1000 points is required as a minimum score on SAT exam (Scholastic Aptitude Test/Scholastic Assessment Test).

In order to enroll in the first year of the first cycle at IUS, applicants must submit the following documents:

1. Application form in which applicants must indicate the faculty (and study program) to which he/she applies (available at www.ius.edu.ba or at the Student Affairs Office);
2. Original and certified copy of the high school diploma;
3. Original and certified copies of the high school certificates for 1st through 4th grade (officially recognized foreign diploma for the applicants who gained their high school education outside Bosnia and Herzegovina or proof that the recognition of foreign diploma process has been initiated);
4. Birth Certificate;
5. Certificate of Citizenship or a passport copy for the applicants who are not citizens of Bosnia and Herzegovina;
6. Two photos, size 6x4;
7. Health Certificate (submitted when signing the studying contract);
8. CIPS certificate.

In case that insufficient number of students are admitted, the University may extend the deadline for submission of documents and publish amended list of the admitted students by the October 15, 2015 the latest. First time applicants as well as those who have not applied before can submit their applications in the second call for the enrolment.

Applications which are incomplete or not sent on time will not be taken into consideration.

Application deadline is September 16, 2015.

IUS will publish preliminary rank-list of all applicants and those who are admitted to the IUS faculties on the IUS notice board and IUS website after it is verified by the competent University body, within two days from the due date for submitting applications for enrolment.

Applicants have a right to submit an appeal on the preliminary rank-list within three days from the day it was published.

IUS will announce the final list of admitted students no later than eight days after the preliminary rank list has been published.

Registration of the admitted students and signing of study contracts will be conducted until the beginning of lectures in academic 2015/16 in accordance with the IUS regulations.
